

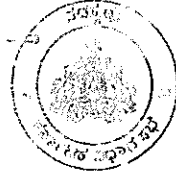

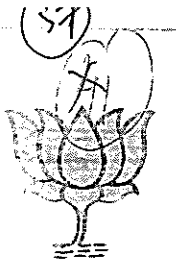

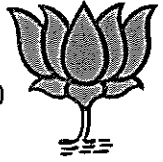

We are the residents of Bommanahalli Village for many decades. Our village has given land for road widening for NH more than 3 times. They have demolished building more than 3 times. Now the road is 200 feet. The service roads itself are 60 feet, the said road has more than 3-4 Hindu Temples. All these temples were demolished three times and were reconstructed. We collected money from village people for this. There is a hospital (Prashanth Hospital) for past 22 years. Even that was demolished three times and reconstructed. There are so many buildings and important structures on the way from Silk Board to Bommanahalli Village.

Now BMRCL has proposed road widening to acquire land for Metro construction. We once again stand to loose our valuable land, buildings, hospital and other important structure. Earlier, there was a proposal for construction of Metro line on the service road, which is more convenient and that will avoid acquiring more valuable properties along this corridor. We request you to construct the proposed Metro line either underground or on the service road to avoid unnecessary hardships and difficulties (Physical, Financial, Employment, etc.,) for the common man. 
