**NOTICE INVITING TENDER**

Bangalore Metro Rail Corporation Ltd., (BMRCL) a Joint Venture of Government of India and Government of Karnataka invites sealed tenders from eligible bidders for 'Shifting of BESCOM utilities infringing elevated Metro corridor alignment of REACH-2, PHASE-II, From VRL Godown (Near RV College) to Doddabele - Chellaghatta on Mysore Road - Package 4,' Bangalore.

A. Details of the Tender are as under:

- B. Bids not covering the entire specified scope shall be treated as incomplete and rejected.
- C. The Interested eligible bidders may obtain further information on BMRCL website [www.bmrc.co.in](http://www.bmrc.co.in). The bid documents would be available on prescribed payment **from 14.11.2016 to 13 .12.2016 up to 12.00 hours.**
- D. A complete set of non transferable bid documents may be obtained on payment of non-refundable fee of INR 10,000/- (Indian Rupees Ten thousand only) in the form of DD/pay order in favour of BMRCL, payable at Bangalore by sending a written request. In case of

- any difficulty or clarifications the same can be obtained from the Chief Electrical Engineer (Phase-II), BMRCL, III Floor, BMTC Complex, K.H. Road, Shanthinagar, Bangalore-560 027 on all working days during the working hours till the last date of sale of documents.
- E. Completed Bids shall be submitted along with the EMD in the form of Demand Draft/Bank Guarantee payable at any designated branch in Bangalore, as mentioned against EMD column and ITT clause 16. The EMD shall cover the entire validity period of the bid plus 30 days including period of extension if any, required by BMRCL.
- F. Bids shall be submitted in 3 sealed envelopes / covers separately for viz. (i) The EMD (ii) Technical Bid and (iii) Price Bid, both Technical & Price bids shall be in duplicate in separate sealed covers. All the three shall be enclosed in an outer sealed cover.
- G. Bids will be received from **up to 15.00 hours on 13.12.2016**. The technical bids will be opened in the presence of the bidder or his authorized representative who choose to attend, at the office of BMRCL **on 13.12.2016 at 15.30 hours** If the office happens to be closed on the last day of issue or receipt of the bids for any reason, the bids will be issued or received and opened on the next working day of the office at the same venue and time.
- H. The Price bids of technically qualified bidders will be opened at a later date under intimation to such bidders only in the presence of bidders/representatives who choose to be present. Bid security of bidders not technically qualified will be returned through registered post only after award of the contract to the successful bidder.
- I. The bidder shall provide credentials in support of the qualifying criteria, technical capability, financial strength and past experience by supporting documents / client certificates / CA's audit reports.
- J. BMRCL takes no responsibility for delay, loss or non-receipt of bid document sent by post / courier /either way. Further, BMRCL reserves the right to reject any or all the bids without assigning any reasons thereof and shall bear no liability whatsoever consequent upon such a decision.
- K. **Financial/Technical Eligibility Criteria for Bidders:**
1. The Bidder should have a valid **“Class-1 Electrical License”** issued by the Electrical Inspectorate, Govt. of Karnataka. Notarized copy of the License shall be furnished. Original Document of the license will have to be produced for verification by BMRCL after opening of the Technical bid as requested.
  2. The bidder should have experience in creation of Distribution networks of HT/LT both underground and overhead and should have completed similar works during the last five years ending 31.03.2016. and fulfill the following to establish the same:
    - i. The bidder should have completely executed at least **one similar works** during the last five years ending 31.03.2016 of value not less than **Rs. 1,40,00,000/-** (Rupees One Crore and Forty Lakh only).( 50% of Tendered value ) The Bidder shall furnish clients' certificates in support of the same.  
Or
    - ii. The bidder should have completely executed at least **two similar works** during the last five years ending 31.03.2016 each of value not less than **Rs. 1,12,00,000/-** (Rupees One Crore and Twelve Lakh only).(40% of Tendered value) The Bidder shall furnish clients' certificates in support of the same.  
Or
    - iii. The bidder should have completely executed at least **three similar works** during the last five years ending 31.03.2016 each of value not less than **Rs. 84,00,000/-** (Rupees Eighty Four Lakh Only)(30% of Tendered value) The Bidder shall furnish client's certificates in support of the same.
  3. The bidder should have an average annual turnover during the last three financial years ending 31.03.2016, of at least **Rs. 3,50,00,000.00** (Rupees Three crores and Fifty Lakh

only) (125 % of Tendered value) The **Bidder** shall furnish copies of audited and certified financial reports in support of the same, for the financial years 2013-14, 2014-15 and 2015-16

4. The Bidder should not have been black listed by any government Department/Public sector under takings (PSU). The Bidder should furnish a declaration to that effect.
5. The bidder should not have history of litigation and should not have been black listed by BESCOM or erstwhile KEB or by any department of Government of Karnataka and any other Central Government department including PSUs. An undertaking to that effect shall be furnished.
6. Joint Venture of Consortium is not allowed.
7. **(i) For Fresh Bidders.**

#### ii) For BMRCL Working Contractors (Those who are already working in BMRCL as Contractor):

Contractors already working with BMRCL, who intend to participate in the tender, shall possess the following additional requirements for qualifying in the Bid.

- a) Annual average turnover mentioned in clause K(3) above, should be equivalent to the sum of the turnover required for the works they are already carrying out in BMRCL and the turnover required for the tendered works.
- b) Separate team of personnel is required to be deployed for each works, particularly the Project Engineers and the Site Engineers. The curriculum Vitae of the personnel deployed/to be deployed shall be furnished as detailed in Clause (c) below.
- c) The details of deployment of the following personnel should be furnished in format II
  - 1) Project Manager.
  - 2) Project Engineer.
  - 3) Site Engineer.

Notwithstanding anything stated above or elsewhere in the tender specification, BMRCL reserves the right to relax the qualifying requirements and assess the capability/suitability of the Bidder to perform the overall contract should the circumstances warrant such assessment in the overall interest of BMRCL.

Bidder shall have adequate erection facilities and capacities. The Bidder shall have quality assurance plan for procuring of materials, erection and commissioning. The Bidder shall furnish documentary evidence in support of the qualifying requirements stipulated as above.

Bid documents will be issued to Bidders on the strength of their claim in good faith. However such issue of Bid document will not automatically mean that Bidders are considered qualified. Such qualification will be reviewed again at the time of the evaluation of the bids. Intending parties who fulfill the qualifying requirements are advised to visit the sites to familiarize themselves with the nature and quantum of works & site conditions.

- L. The Bidder shall furnish copies of audited and certified financial reports in support of the same, for the financial years 2013-14, 2014-15 and 2015-16.
- M. The Bidder shall furnish documentary evidence in support of the qualifying requirements stipulated above.
- N. Issue of Bid document will not automatically mean that Bidders are considered qualified, and it is subject to evaluation by BMRCL. Intending parties who fulfill the qualifying requirements are advised to visit the site to familiarize themselves with the nature of work & site conditions.

- O. Late Tenders, received after stipulated time of submission of bid on the specified date, shall not be accepted under any circumstances.
- P. Tenders shall be valid for a period of 90 days from the latest date of submission of Tenders and shall be accompanied with a Earnest Money Deposit (EMD) of the requisite amount in the form of a Demand draft or Pay Order or Bank Guarantee valid for 120 days from the date of submission of Tender described in paragraph 16.0 of the Instructions to Tenderers (ITT).
- Q. A firm after purchase of the Tender documents in their name can submit Tender in the same name.
- R. BMRCL reserves the right to accept or reject any/all tenders without assigning any reasons. Tenderer shall not have any cause of action or claim against BMRCL for rejection of his Tender.
