SHORT TERM TENDER NOTIFICATION

Bangalore Metro Rail Corporation Ltd.,(BMRCL) a Joint Venture of Government of Karnataka and Government of India, **Limited** invites sealed tenders from eligible agencies for 'Shifting of BESCOM utilities infringing elevated Metro corridor alignment of REACH-2 PHASE-II from R.R. Nagara entrance to R.V College compound –on both sides of Mysore road.

Financial/Technical Eligibility Criteria for Bidders:

1. The Bidder should have a valid class-1 electrical license issued by the Electrical Inspectorate, Govt. of Karnataka. Notarized copy of the License shall be furnished. Original Document of the license will have to be produced for verification by BMRCL after opening of the Technical bid as requested.
 2. The bidder should have experience in creation of distribution networks of HT and LT both underground and overhead and should have completed similar works and fulfill the following to establish the same:
 - a. The bidder should have executed at least one similar completed work during the last five years ending 31.03.2014 of value not less than. Rs.62,53,600/-/- (Rupees Sixty two Lakh fifty three thousand Six hundred only). The Bidder shall furnish clients' certificates in support of the same.

- b. The bidder should have executed at least two similar completed works during the last five years ending 31.03.2014, each of value not

less than Rs.39,08,500/-(Rupees Thirty nine lac Eight thousand five Hundred only).The Bidder shall furnish clients' certificates in support of the same.

Or

c. The bidder should have executed at least three similar completed works during the last five years ending 31.03.2014 each of value not less than Rs.31,26,800/-Rupees Thirty one lakh twenty six thousand Eight hundred only).. The Bidder shall furnish client's certificates in support of the same.

4.The bidder should have an average annual turnover during the last three years ending 31.03.2014, of at least Rs.97,71,250/- (Rupees Ninety seven lakh seventy one thousand two hundred and fifty only).

5 The Bidder shall furnish copies of audited and certified financial reports in support of the same, for the financial years, 2011-12, 2012-13.and 2013-14.

6. The Bidder should not have been black listed by any government department. The Bidder should furnish a declaration to that effect.

ii) For BMRCL Working Contractors

Contractors already working with BMRCL, who intend to participate in the tender, shall possess the following additional requirements for qualifying in the Bid.

- a) Annual average turnover mentioned in clause (4) above, should be equivalent to the sum of the turnover required for the works they are already carrying out in BMRCL and the turnover required for tendered works.
- b) Separate team of personnel is required to be deployed for each works, particularly the Project Engineers and the Site Engineers. The curriculum Vitae of the personnel deployed/to be deployed shall be furnished as detailed in Clause (c) below.
- c) The details of deployment of the following personnel should be furnished in format II.
 - 1) Project Manager.
 - 2) Project Engineer.
 - 3) Site Engineer.

8. Joint venture or a consortium is not allowed.

Notwithstanding anything stated above or elsewhere in the tender specification, BMRCL reserves the right to relax the qualifying requirements and assess the capability/suitability of the Bidder to perform the overall contract should the circumstances warrant such assessment in the overall interest of BMRCL.

Bidder shall have adequate erection facilities and capacities. The Bidder shall have quality assurance plan for procuring of materials, erection and commissioning. The Bidder shall furnish documentary evidence in support of the qualifying requirements stipulated as above.

Bid documents will be issued to Bidders on the strength of their claim in good faith. However such issue of Bid document will not automatically mean that Bidders are considered qualified. Such qualification will be reviewed again at the time of the evaluation of the bids. Intending parties who fulfill the qualifying requirements are advised to visit the sites to familiarize themselves with the nature and quantum of works & site conditions.

COMPLETION PERIOD:

A) Time is the essence of this contract. Period of completion from the date of letter of award (LOA) for the entire work is **-180 Days**.

B) If an existing cable is damaged and to be provided with one/two numbers of straight through joint/s without any additional cable/with small cable piece up to a length of 10 m, the same shall be completed within 2 to 3 days from the date cable is identified for jointing.

C) The contractor shall complete any specific work of cable shifting(less than 50 m length) within 15 days from the date cable is identified and notice to start the work is intimated orally/in writing by Engineer-in-Charge.

D) The contractor shall complete any specific work of cable shifting(more than 50 m length) within 30 days from the date cable is identified and notice to start the work is intimated orally/in writing by Engineer-in-Charge.

E) The contractor shall complete pole mounted transformer shifting works/ providing new spun pole with structure materials (item no.39 of BOQ) within 30 days from the date location is identified and notice to start the work is intimated orally/in writing by Engineer-in-Charge.

Tender documents can be obtained from 17/09/2014 to 17/10/2014 during the office working days and hours on payment of the above mentioned tender document cost in form of DD drawn in favour of Bangalore Metro Rail Corporation Limited payable at Bangalore along with a requisition letter.

Date of submission of sealed tender documents is up to 17/10/2014 during office hours between 11.00 hours and 15.00 hours (IST).

Tenders will be opened on 18/10/2014 at 15.00 hours (IST) in the presence of the available bidders/representatives of the bidders.

The tender opening shall be in two parts. The Technical Bid shall be opened on the tender opening day as mentioned above. The Financial Bid of the technically qualified bidders shall be opened on the notified day.
